



OFFICIAL MEMORANDUM

Sub: Courts and Judges – Newly appointed Civil Judges - Training as interns to Hon'ble Judges, High Court, Madras for a period of two months, from 04.09.2017 to 03.11.2017 – Letter of the Director, TNSJA, Chennai requesting to nominate newly appointed Civil Judges, to undergo Training – Considered – Officers nominated – Orders issued.

The Director, Tamil Nadu State Judicial Academy, Chennai, in the letter under reference cited, has stated that the Hon'ble Governing Body of TNSJA has directed the Director, TNSJA, to impart training to the newly appointed Civil Judges, who did not undergo the two-months' intensive training programme at TNSJA, as interns to Hon'ble Judges, High Court, Madras, for a period of two months, and prepare a schedule, incorporating the observation of court proceedings at the Principal Seat of the High Court of Madras and the City Civil Court, Chennai.

He has further stated that as directed, TNSJA has prepared a schedule as below for the aforesaid training programme for a period of two months from 04.09.2017 to 03.11.2017 and it was approved by the Hon'ble Governing Body of TNSJA :-
