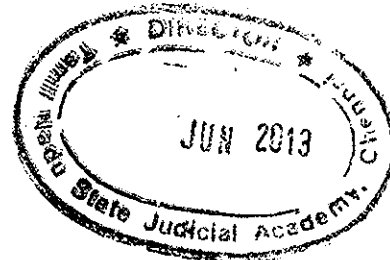

Sub: Court and Judges - various Training Programmes for Ministerial Staff at the District Headquarters - to enhance their knowledge and skills - Scheduled to be conducted during the year - "Training for Trainers" programme to be conducted at Tamil Nadu State Judicial Academy, Chennai on 29.06.2013 - Nomination of Judicial Officers and Staff Members of the District Judiciary as Trainers - Requested - Aforesaid Training Programme postponed to 30.06.2013 - **Only Judicial officers in the cadre of Senior Civil Judge** who have been nominated by the Principal District Judges/ District Judges - to be deputed to attend the aforesaid training programme - Orders issued.

The Principal Judge, City Civil Court, Chennai, all the Principal District Judges / District Judges and the Chief Judge, Pondicherry were directed in the High Court's letter under reference 2<sup>nd</sup> cited,

- B
- (i) to nominate atleast three Judicial Officers preferably in the rank of Senior Civil Judge.
  - (ii) to nominate atleast three staff members in the cadre of Sherishtadars / Head Clerks with atleast three years of service remaining and
  - (iii) to forward the said lists of nominated Judicial Officers / Staff Members, to the Director, Tamil Nadu State Judicial Academy, Chennai immediately, to enable to conduct "Training for Trainers" Programme at the Tamil Nadu State Judicial Academy, Chennai on 29.06.2013 (Saturday).

The Director, Tamil Nadu State Judicial Academy, Chennai in his letter under reference third cited has informed that the programme "Training for Trainers" scheduled to be conducted on 29.06.2013 (Saturday) at the Tamil Nadu State Judicial Academy, Chennai has been postponed to 30.06.2013 (Sunday) and **only Judicial Officers in the cadre of Senior Civil Judge** who have been nominated by the Principal District Judges/District Judges of all the Districts have to be deputed for the aforesaid training Programme rescheduled to be held on 30.06.2013.

As directed, the Principal District Judges/District Judges of all the Districts, Principal Judge, City Civil Court, Chennai and the Chief Judge, Puducherry are directed to depute only <sup>to</sup> **Judicial Officers in the cadre of Senior Civil Judge** who have been nominated by them for the programme "Training for Trainers" initially scheduled to be held on 29.06.2013 at Tamil Nadu State Judicial Academy, Chennai to attend the programme which has now been rescheduled to be held on **30.06.2013 (Sunday)**.

Accommodation for the participating outstation Judicial Officers will be provided if required in the premises of the Tamil Nadu State Judicial Academy and in this regard they may confirm the same to the Tamil Nadu State Judicial Academy on or before 27.06.2013.

The nominated Judicial Officers in the cadre of Senior Civil Judge are required to report before the Director, Tamil Nadu State Judicial Academy, Chennai at 8.30 a.m. on 30.06.2013, to attend the aforesaid programme "Training for Trainers".

Breakfast, Lunch and Coffee with snacks will be provided at the venue.

The nominated officers from outstations are permitted to claim T.A./D.A. in this regard, as per rules in force.

The absence of the Officers attending the said programme from the Headquarters / Office in this regard, is treated as on other duty.

The nominated Judicial Officers are informed that any request for exemption from participating in the said programme will not be entertained.
